## SWIMMERS SHOULD KEEP A PERSONAL RECORD OF EVENTS ENTERED

**Meet.** This meet is the North Lancs No Frills Meet aimed to help swimmers gain a ranking time. Due to the covid it has been decided to hold this on 2 separate dates, one at Palatine Pool Blackpool on Sunday 3 October, and one at Darwen Pool on Sunday 10 October. The same programme will be held at each venue. Clubs have been allocated a pool. Both pools are equipped with Electronic Timing. The competition is open to swimmers who are registered with clubs affiliated to North Lancashire.

## **Clubs Allocated Pool: -**

**Palatine (3 Oct)** – Blackpool Aquatics, Carnforth, Fleetwood, Garstang, Kendal, Kirkham & Wesham, Lancaster, Lytham St. Annes, Ormskirk, Preston.

**Darwen (10 Oct)** – Blackburn, BOBCATS, Chorley Marlins, Clitheroe, Colne, Great Hartwood, Leyland Barracudas, Pioneer 79, Southport, Prescot.

**Closing date** for all entries midnight Tuesday 21 September 2021. Entries received after this time will not be accepted.

Age on the day will be as of midnight on 3<sup>rd</sup> October 2021 for those at Palatine and midnight 10<sup>th</sup> October for those at Darwen..

The Age Groups will be 9, 10, 11, 12, 13, 14/Over as at midnight on the above dates.

Entry fees - each event £4.00

**Coaches and Chaperones** requiring access to the event must be a member of a club competing and be in possession of a pass issued by North Lancs S&WPA by completion of the appropriate form. It is mandatory that all coaches and chaperones comply with the relevant SE Child Safeguarding procedures and have an up to date DBS certificate.

**Consideration Times** (25m Pool Size) required for all events. Please check the correct age group is entered relative to the swimmers date of birth. The requirement of having achieved a consideration time in order to enter for an event relies significantly on the integrity of coaches, swimmers and parents to submit correct, truthful information. **No refunds for mistakes.** 

**Eligibility for entry.** The competitions shall be open to eligible swimmers, as defined by SE, who are members of clubs affiliated to North Lancs S&WPA. A swimmer must have been a member of the club in whose name they are entered and registered as such with SE at the closing date for entries.

Details on the entry forms should be as per the swimmers SE Category 2 Membership Registration. Please check that your swimmers (including 9yr olds) are Category 2 registered, their SE ID number, times and other details are correct before submitting. For processing of entries all details must be fully completed. Entries sent without fee, with entries incorrectly made out or declaration not signed may not be accepted. **No refunds for entries incorrectly submitted**. Entries to be sent electronically by an authorised club official. Cheques payable to North Lancs S&WPA.

**Over the top starts** may be in operation which may include backstroke. The heats shall be swum all ages seeded together.

**Withdrawals** must be made on an official withdrawal form or by phone to mobile number 07508 427444 from Thursday 30<sup>th</sup> September (Palatine) and Thursday 7<sup>th</sup> October (Darwen)July 2021. To help the event run smoothly withdrawals must be made no later than 45 minutes before the start of a session.

### No Frills Meet - No awards will be given.

**Competitors** are responsible for presenting themselves to the clerks of the course in good time for the event in which they are competing. It is the swimmers' responsibility to be at the start in time for the race.

**Restriction of entries.** The promoter reserves the right to restrict entries in the interest of safety, time constraints and to ensure the smooth running of the competition. Where this rule is invoked the swimmers with the fastest submitted times shall take precedence. Events chosen for restriction will be at the discretion of the promoter. A refund will be given to competitors whose entry is denied where this condition has been exercised.

#### **Data Protection**

Meet entries shall be managed on a computer. Your consent to the holding of personal information for the purposes of the Meet shall be treated as being given by the submission of your entries, as shall your consent for such details to be published both during and after the meet.

#### Photography

No photography is permitted in the pool hall at Palatine. No mobile phones will be permitted on poolside.

### Strobe

A strobe is available at Palatine.

**Spectators** – No spectators at this event.

Any question or dispute arising from these conditions or disputes related to a matter not covered in these conditions shall be determined by the Age Group Secretary and may be referred to the North Lancs Executive Committee at a later date.
